I finished M.L. and became the Professor of Law in Government Law College, Trichy and become the President of The Tamilnadu Law Teachers Association and Syndicate Member of The Tamil Nadu Dr. Ambedkar Law University. I wrote a book in Family Law which was released by the then Chief Minister of Tamilnadu Hon. Jayalalitha. After my retirement from the Government service, I joined as Professor of Sastra University, Tanjavur. Recently in the Month of January 2018, I assumed office of the Dean, School of Law, BSA Crescent Institute of Science and Technology.

The Crescent School of Law, is the dream, dreamt by the founder of our prestigious institution and was established in the year 2017 with the objective of providing quality legal education to the students of rural and urban areas. The School offers Five Year BBA. LLB (Hons) and B.Com. LL.B. (Hons) Integated Programme and the same was approved by the Bar Council of India.

The present world is global, competitive and complex and the "issues" that are confronting are also on the same span. To translate the above vision the Crescent School of Law came into existence with a mission to spread quality education. Quest for quality in legal education is the cry of the day and the Crescent School of Law has taken the same as its mission.

The School was inaugurated by Honorable Former Judge of Supreme Court of India Justice F.M. Ibrahim Khalifulla on 20th September 2017. The other dignitaries present on the occasion include Justice

A Special lecture was conducted on the topic "Fundamental Rights and Duty" on

18. 9.2018. The lecture was given By Dr.B Gandhi, Dean, VIT School of LAW. He Highlighted the importance of fundamental rights, its relationship with the Directive principles of state policy. He emphasized more on fundamental Duties before claiming fundamental rights because the rights and duties are correlative.

In order to provide justice to the common people and to create awareness among the people to get their justice as per the guidance of Bar Council of India, the School of Law has established Legal Aid Clinic under the Supervision of a Senior Professor. The legal aid clinic will be opened during 9.00 am - 4.00 pm in all working days and also there is a Proposal to conduct Legal Aid Programme in the nearest villages in collaboration with the Legal Aid Authorities. This is with the view to fulfill the spirit of the Preamble of our Constitution which guarantees Social, Economic and Political Justice to all people irrespective of caste, creed, religion, race, place of birth and so on.

The School is having a Moot Court society to train the students to participate in Moot Court Competitions and

to train them in Court Skill and Deliberation. As a maiden attempt, our first year students Sujan and Showkiya were sent to participate in the state level moot court competition conducted by the Bar Association of the Madurai Bench of the Madras High Court in April 2018 and they were adjudged as the young participants of the competition by giving a certificate of appreciation.

The Crescent School of law conducted the International Women's Day. It was a good session and the students expressed their ideas to arrest the crimes against women.
